The regular monthly meeting held on January 8, 2013 at town meeting room, 56 Geneva St. Dresden and was called to order by Supervisor Flynn at 7:30PM.

Mr. Flynn presented the abstracts of vouchers for review and approval.

Jim Balyszak Director of Yates County Soil & Water explained the services his department will provide for Watershed coverage for the Village and Town for the year 2013. The Town will receive reports monthly and will be billed quarterly.

Code/Watershed Report- 4 footers, 4 foundations, 1 fence, 2 Finals, 2 framing, 2 reviews 84 Miles, also presented a of 2012 summary permits/ renewals. Watershed report – 2 inspections 16 miles with 2012 summary of watershed inspections, calls and request for information.

Discussion whether a legal representative for the Town should attend this meeting. Clerk will contact Dean Heberlig of Bond Schoeneck & King who represented the Town with AES before.

Clerk reported Justice Mashewske's concern over pending matter in town court. Clerk will contact Atty. Kathy Bennett request update for Judge.

Discussion on drafting of Hydo fracking/ directional drilling law. A committee to draft such law is being formed. Names were suggested and will be contacted for interest of being part of this committee.

Letter from George Thompson presented. Wastewater law has not been re-drafted, Mr. Thompson requested to be added to information link.

Motion by Mr. Flynn to move into executive session for a personnel issues 2nd by Mr. Martini at 8:30 PM. Mary Lilyea was invited into the session to discuss another pending legal issue.
