## Town Board Minutes July 9, 2013

The monthly meeting of the Torrey Town Board was held on July 9, 2013 in the town meeting room at 56 Geneva St Dresden and was called to order by Supervisor Flynn at 7:30PM

Others present: Jeff Finger- Highway Supt., George Thompson, Dwight James- Code Officer, Mary Lilyea- Assessor, Tim Dennis- District Legislator, Jim Smith

Mr. Flynn led the Pledge of Allegiance.

Mr. Flynn presented abstracts of vouchers for audit.

Motion by Mr. Martini 2<sup>nd</sup> Mr. Morris,that the bills on the General A & B accounts in the amount of \$13,554.26 be paid, carried by all.

Motion by Mrs. Francisco, 2<sup>nd</sup> Mr. Morris that the bills on the Highway DA & DB in the amount of \$62,454.56 be paid, carried by all.

Motion by Mr. Flynn 2<sup>nd</sup> Mr. Martini, adopting a policy of no tobacco use on the Town Public Beach property at 73 <sup>1</sup>/<sub>2</sub> Charles Street , Dresden NY . Carried by all.

Signs prohibiting will be attached to the beach house on front facing parking lot and the side wall facing the playground.

Although the Town has a non- smoking policy on all of Town property in place already, this new policy will address "smokeless tobacco" under "no tobacco use".

Motion by Mr. Martini 2<sup>nd</sup> Mrs. Francisco to approve the June minutes carried by all,

Jeff Finger gave the highway report. The mowing tractor is having mechanical issues and may need to go in for repair. The 125 Case Hoe blew a hydraulic hose and the repair was \$ 1200. Parts are hard to find and questionable for future repairs. Asked of hours it is used on roads. Mr. Finger stated it is used very little, if need arose he would rent a hoe by the week/month. After a lengthy discussion, the board moved on to the rock crusher. I t has not been used in a long time and there is no use for it, Mr. Morris made a motion to declare the 125 Case Hoe and the rock crusher surplus, to be advertised for sale, carried by all.

Mr. Finger will research the best way to advertise via bids in the newspaper or internet. Board determined worth of hoe at @ \$ 20,000 and the rock crusher at @ \$ 5,000.

Dwight James- Code Officer gave his monthly report; 3 Site visits, issued 6 Building permits, 5 C of C, 1 Area Variance, 8 Building progress inspections, 5 violation inspections. 2 meetings w YCSW, Completed 1<sup>st</sup> set of classes. 288 miles traveled.

Jim Smith of Serenity Rd introduced himself as a candidate for YC Legislator District # 2 seat.

Discussion with Tim Dennis regarding the County budget's future. He stated there is a meeting with the State Retirement System. There will be a presentation from a representative on the pension contribution leveling proposal in August. The County treasurer will be sending out more information on this. He urges board members to attend.

There being no further business before the board, Mr. Flynn made a motion to adjourn,  $2^{nd}$  by Mr. Martini and carried at 7:50pm.
