November 12, 2013

The monthly meeting of the Torrey Town Board was held on November 12, 2013 in the town meeting room at 56 Geneva St Dresden and was called to order by Supervisor Flynn at 7:30PM

Mr. Flynn led the Pledge of Allegiance.

Mr. Flynn presented the abstracts of vouchers for audit.

Motion by Mr. Petersen,, 2<sup>nd</sup> Mr. Morris, that the bills on the General A & B accounts in the amount of \$ 6,058.72 to be paid, carried by all.

Motion by Mr. Morris 2<sup>nd</sup> Mr. Martini, that the bills on the Highway DA & DB accounts in the amount of \$ 10,055.98, be paid, carried by all.

Motion by Mr. Martini, 2<sup>nd</sup> Mr. Morris, that the bills on the Final installation of the 2013 Fire contract in the amount of \$ 36,000.00 to be paid, carried by all.

Mr. Flynn presented the zoning changes recommended by the Town Planning Board. He then called for a Local Law public hearing on the proposed changes to Zoning Law. Public hearing will be set for December 10<sup>th</sup> 2013 at 7:30PM.

Motion by Mr. Martini 2<sup>nd</sup> Mr. Petersen to approve the October 8<sup>th</sup> minutes carried by all.

Motion by Mr. Flynn 2<sup>nd</sup> Mr. Morris appointing Caitlin Callaway as dog enumerator for 2013 / 2014 carried by all.

Highway Supt. Finger reported that he went and visited Hawk Frame to get an update on " Torrey 3" the town's 10 wheeler truck in for frame repair. More extensive corrosion was found will be removed and that area will also be repaired. The highway crew is completing routine equipment maintenance. A plow truck on loan from Milo is also being serviced Dave Bond will use this truck for plowing and sanding until his truck is finished at Hawk Frame.

Code Officer James gave his monthly report. 6 Site visits, 2 Building permits, 1 C of C, 3 Area Variance, 1 Steep Slopes permit, 3 Site Plan visits, 4 Building progress inspections, 7 violation inspections. 1 short term rental, Completed 5th set of code classes. 330 miles traveled.
