

Town Board Minutes  
December 10, 2013

The monthly meeting of the Torrey Town Board was held on December 10, 2013 in the town meeting room at 56 Geneva St Dresden and was called to order by Supervisor Flynn at 7:30PM

Mr. Flynn led the Pledge of Allegiance.

Mr. Flynn presented abstracts of vouchers for audit.

Motion by Mr. Morris 2<sup>nd</sup> Mrs. Francisco, that the bills on the General A & B accounts in the amount of \$ 28,173.01 be paid, carried.

Motion by Mr. Petersen, 2<sup>nd</sup> Mrs. Francisco, that the bills on the Highway DA & DB in the amount of \$ 43,733.05 be paid, carried by all.

Motion by Mr. Flynn 2<sup>nd</sup> Mr. Morris approving the November minutes, carried.

Mr. Flynn presented Local Law 01-14 a law amending the Zoning Law and Steep Slopes Law. This is to correct editing errors and clarify making the laws more readable. Public Hearing on this law will be January 14, 2014 at 7:30pm in the town meeting room at 56 Geneva Street, Dresden, NY.

Motion by Mr. Flynn, 2<sup>nd</sup> Mr. Petersen authorizing the sale of the 2011 Ford pick up with plow attachment on Auction International when available, carried.

Mr. Petersen reported that the Culvert Project is completed. All the culverts within the Town were compiled into a report with information, map location and photos. The Board commended him on his diligent time spent completing this project. This report will be a asset for the highway department with road maintenance.

Dwight James- Code Officer gave his monthly report; 2 Site visits, issued 6 Building permits, 1 C of C,0 Area Variance, 19 Building progress inspections, 7 violation inspections. 2 meetings w YCSW, Completed 6th set of code classes. 368 miles traveled.

He would like to explore a inter-municipal agreement with the Town of Benton for Code coverage in case there is ever a need due to sickness or vactions. This would be a shared service agreement.

Mary Lilyea gave an update on the Star program, in Torrey there are only 58 properties not reregistered.

There being no further business before the board, Mr. Flynn made a motion to adjourn, 2<sup>nd</sup> by Mr. Morris and at 8:10pm.
