

Town Board Minutes  
January 11, 2010

The regular January meeting of the Town Board held at 56 Geneva St. Dresden, was called to order at 7:30 PM by Supervisor Flynn.

Present: Patrick Flynn, Councilmen; Burge W. Morris, John Martini, Linda K. Francisco, Colby Petersen

Supervisor Flynn, Councilmen- Petersen and Morris were given their oaths of office by the clerk.

Mr. Flynn welcomed and introduced newly elected Councilman Colby Petersen.

Mr. Flynn led the pledge of allegiance.

Mr. Flynn presented the abstract of vouchers for audit review.

Motion by Mr. Martini 2<sup>nd</sup> Mrs. Francisco that the bills on the General A & B accounts, in the amount of \$ 22,730.36 to be paid, carried by all.
