

Town Board Minutes  
November 12, 2019

The monthly meeting of the Torrey Town Board was held on Tuesday November 12, 2019 at 56 Geneva St. Dresden NY and called to order by Supervisor Flynn at 7:30PM.

Mr. Flynn led the pledge of allegiance.

Mr. Flynn presented the abstract of vouchers for review.

**General A & B Fund** Motion by Mr. Martini, 2<sup>nd</sup> Mr. Petersen, that the bills on the General A & B accounts in the amount of \$ 21,201.59 be paid, carried.

**Highway DA & DB Fund** Motion by Mr. Petersen, 2<sup>nd</sup> Mr. Downs, that the bills on the Highway DA & DB accounts, in the amount of \$ 5,724.91 be paid, carried by all.

**2019 Fire Contract** Motion by Mr. Martini, 2<sup>nd</sup> Mr Petersen, to pay the third installment of the Fire Contract in the amount of \$ 32,900., carried by all.

**Minutes** Motion by Mr. Martini 2<sup>nd</sup> Mr. Downs to approve October minutes with noted corrections, carried by all.

**Highway Report:** Tim Chambers gave the highway report.

Mowing for 2019 is completed. He plans to use the side mower on the excavator to clean up bank along the roadways this winter. Made repairs to approaches on three driveways.

Doug did repairs on and repainted loader, a nice job.

Could not get T-3 inspected at County Highway. The County is out of inspection stickers due to higher volume of truck inspections from to the closing of Tones Garage.

Took T-3 to Geneva to Regional International for inspection.

Did not pass due to needed work. Doug working on repairs now.

Inspection sticker runs out end of December.

Winter came early, sanding and plowing since the 7<sup>th</sup>. Sent for quotes on new dump truck.

No action yet on East Leach Rd Mr. Petersen is working on RFP for project.

**Code Report-** Dwight James reported 6 permits for October 1 C of C, 1 Sub Division application, 1 lot line adjustment, 2 complaints, 8 building inspections, 16 meetings, 101 miles.
