round roadsides. T-2 dumpbox revamping will be completed next week. Box had to be raised to accommodate other equipment. Presented quotes for new loader from Milton Cat 2019 \$152,471. And 2022 \$ 168,000. John Deere quote was \$ 186,000. No action taken

Due to the ongoing erosion issues the beach will remailed closed as a safety caution.

Mr. James gave a Code Report, traveled 167 Miles.

Mr. Downs inquired on progress of Torrey Station, Mr. James stated this is now in DEC hands for non-compliance issues.

Mr. Petersen gave the watershed report. In 2020 there were 97 inspections 21 past due, completed 2021 there are 42 inspections. Brief discussion on failed systems.

Gary McIntee brought up discussion on public notices. Many resident do not read Chronicle Express the official newspaper of the Town. He would like to see the noticed digitalized but Chronicle does not. Discussed whether to use Dundee Observer for legal postings. Legal notices can be put on Town website under news/events. No action taken

Mr. Downs has three quotes for the park sign KG Graphics 850.

CQsiqns - 2785.

TopDog signs - 1085.

Motion by Mr. Martini 2^{nd} Mr. Martin to accept KG Graphics quote "design option 2" for \$850. Carried by all.

Discussion on Cannabis law pending in legislation. Will add on future agenda, and ask the planning Board to review the Marijuana law.

Received American Rescue Plan \$ 48,111.12, Supervisor will take webinar on the particulars of how and what this money can be used for.

Further discussion on loader and mowing tractor ended due to power failure caused by severe storm.

Mr. Flynn made a motion to adjourn 2^{nd} Mr. Petersen carried at 8:55PM
