<u>January Minutes</u> Motion by Mr. Downs 2^{nd} Mr. Martin to approve the January minutes with correction on attendee and note that no action taken on Cannabis draft.

Abstract of vouchers - Mr. Martini presented the abstracts.

Motion by Mr. Martin, 2^{nd} Mr. Petersen that the bills on the General A & B Accounts in the amount of \$ 47,256.25 be paid, carried by all.

Motion by Mr. Petersen 2^{nd} Mr. Downs, that the bills on the Highway DA & DB Accounts in the amount of \$ 5,322.02 be paid, carried.

Motion by Mr. Petersen, 2^{nd} Mr. Martin, to pay the first installment of the Fire Protection Contract in the amount of \$ 34,500.00 carried by all.

Mr. Chambers gave the highway report. He suggested the personnel policy be updated he will check with the county policy.

New loader may arrive next month questioned where the money will come from, it is not in the 2023 budget.

Mr. Martini stated this is the responsibility of the Supervisor, the money was added into the 2022 budget for the loader and has been encumbered for the loader payment.

Mr. Chambers stated a culvert pipe on Serenity Road needs to be replaced and the highway department will work with Nardozzi as the WD1 water pipe will cross here also. Roadway will be closed for 2 days, Residents will park on Davy Road.

Mr. Chambers reported T-3 is back form Regional International, it had an electrical issue. While T-3 was down the truck borrowed from Benton had to be repaired.

Mr. Chambers has been in contact about Covid Repayment Plan for payroll, due to many fraudulent calls Mr. Martini stated be wary of these kinds of contacts, especially involving employee personal information.

Mr. James gave the Code report. Permits to date 33. 1 Special Use application, 1 site plan review 2 site visits, 5 building progress inspection, traveled 86 miles.

Discussion on setting fees on solar farms, short term rentals and Special Use Permit renewal fees.

Brief discussion on farm land and solar systems. Mr. Petersen will send out a map of prime farmland in Torrey

Phil Correll inquired about red flags along Route 14 are these marking out water district. The red flags have nothing to do with the water district as they are outside the area. When will water come down Route 14 south. Brief discussion about the Route 14 corridor water study, that survey showed positive interest in Torrey and Milo but not Starkey.
