Highway Report Mr. Chambers reported near completion of meter pit installations for Water District 1. Starting reclamation request along line. Received 80 tons salt for this winter ice control. Paved Serenity Road.

Completed shoulder work on Downey Rd. Installed a driveway pipe on David Downey Road for new home.

Highway employees will be attending a Cornell Roads "Local Roads Done Right" training, on October 10 at Town of Benton. Would like to see a rate increase for highway employees to be comparable to other highway departments.

Supervisor stated the Town Board is in the budget process right now therefore the budget has not been completed and the employee rates are set in January. Josh Wood attended for highway employees but did not have comment.

Code Report Mr. James issued 7 permits, 2 pending Special Use applications, 2 Steep slopes applications, 1 Site Plan pending, 3 site visits, 12 building progress inspections, 1 violation resolved, traveled 126 miles.

Assessor Report 10 property sales for August and start of September. Will start printing exemption renewals to be mailed out at end of year. Received two ag exemptions for recently transferred properties. Clinical Aid application has been submitted, will not be awarded until 2025.

At recent training Stephanie received her 20-year certificate from NYS Assessor Association.

Perry Point WD CPL is working on the Map Plan Report Update Have spoke with Greenidge representatives about permission to use their easements for water project and they have been agreeable.

Frank Bush Binghamton Boat Club, Perry Point, inquired about getting electric placed underground along Perry Point Rd.

Gary McIntee Perry Point, asked if there is a timeline for Water District 2 to commence. He also had a question on water rates for the new district.

District II Legislator Terry Button reported on recent Yates Co Legislator business.

Yates Co is planning on exceeding the 2% tax cap for 2025. Kerry Brennan is collecting Relief Supplies for victims in Florida following hurricane damage.

George Roets is moving Mental Health control back to the County from contractors.

Highway millings were distributed throughout the Towns & Villages.

Medical Insurance budget will see an increase of 12-15% Torrey Landfill maintenance Plan needs to be updated Highway structure has been paved and gas turned on. Expected moving in date is November 1.

HEAP grant applications are being accepted now to help defray

annual cost of heating and electric bills by income. Yates Co Soil & Water has Septic Grants available to reimburse up to 50% of septic replacement cost.

Pat Boccacci of Arrowhead Beach inquired about contaminated soil leaching into the lake from Greenidge Lockwood site. Brief discussion on sediment ponds that have been updated onsite.

She inquired about the culvert projects the Town is presently applying for grant funding, can money be used for railroad crossings. She is very concerned about the terrible railroad crossings entering the village and what the town can do. The 3 railroad crossings she spoke of are in the village limits therefore under the control of village. The culvert project is on Perry Point Rd.

Clerk informed Mrs. Boccacci there is contact number for Norfolk Southern Railroad on the backside of each crossing sign.
