

Town Board Re-organizational Meeting  
January 14, 2014

The regular monthly meeting held on January 14, 2014 at town meeting room, 56 Geneva St. Dresden and was called to order by Supervisor Flynn at 7:30PM.

Supervisor Flynn led the Pledge of Allegiance.

Mr. Flynn introduced the newly elected James Smith, District II Legislator.

Mr. Flynn presented the abstracts of vouchers for review and approval.

Motion by Mr. Morris 2<sup>nd</sup> Mr. Martini that the bills on the General A & B account in the amount of \$9,258.57 be paid carried.

Motion by Mr. Petersen, 2<sup>nd</sup> Mr. Martini that the bills on the Highway DA & DB accounts in the amount of \$ 10,878.08 be paid, carried.

Mr. Joseph Carey an agent of Suburban Propane appeared before the board with his concern of propane facility at 1630 Route 14. He stated that it is a financial hardship to keep the trucks in another site. It is a further delay to emergency deliveries. He stated the facility is secured therefore they are in federal compliance with the trucks being parked there. He would like to seek a variance allowing parking on site. The Town Board said to take it to the Zoning Board of Appeals.

**Background on this issue;** The Town Code Officer contacted Crystal Miller of Suburban Propane regarding the parking of propane trucks and storage of small propane tanks within the fenced facility at 1630 Rte. 14 in March 2013. An application to modify the existing permit was submitted in April. Mr. James contacted Town Special Counsel for advice. He was advised the original permit cannot be modified. In Counsels opinion the former Special Use permit (variance) for this facility was issued erroneously. A special use permit would be needed for the parking. Mr. James then sent this to the planning board in August.

The planning board sent a letter stating three options

1. Conform use of the property to that prescribed in the variance issued on 12/20/1994,
2. File for a use variance with the Zoning Board of Appeals to permit parking of trucks and storage of smaller tanks
3. Petition the town to change the Zoning Law in the Community center Zoning District

Since Suburban Propane has used the facility for more than 6 months in violation of the existing variance, they were requested to contact the Code Officer and Planning board within 30 days as to the action they intend to take to resolve the issue.

December 26, 2013 Code Office sent a letter to Suburban Propane requesting that they bring the facility into compliance, by removing all tanks and vehicles on or before 1/10/14, further enforcement action will be taken ( note: the last vehicle was removed 1/9/14)

Mr. Finger presented the bid statement from Auctions International for the Towns 1965 Cat 922 wheel loader. Motion by Mr. Flynn 2<sup>nd</sup> Mr. Petersen to accept the bid \$ 4900. of MD Chandler Trucking of Porters Corners NY, carried by all.

Motion by Mr. Martini 2<sup>nd</sup> Mrs. Francisco, to approve the minutes of December meeting, carried.
