

Town Board Minutes
May 10, 2016

The monthly meeting of the Torrey Town Board was held on May 10, 2016 at 56 Geneva St. Dresden New York and called to order by Supervisor Flynn at 7:30PM.

Present: Supervisor Patrick Flynn, Councilman; Burge Morris, Colby Petersen, Peter Martini and Lawrence Martin

Others present: George Thompson, Dwight James- Code Officer, Grant & Linda Downs, Bill & Jane Crumlish, Richard & Nye Nelson,

Mr. Flynn led the pledge of allegiance.

Mr. Flynn presented the abstracts of vouchers for review.

Motion by Mr. Morris, 2nd Mr. Martini, that the bills on the General A & B accounts in the amount of \$ 5,687.40 be paid, carried

Motion by Mr. Martini 2nd Mr. Petersen, that the bills on the Hwy DA & DB accounts in the amount of \$ 9,827.43 be paid, carried.

Motion by Mr. Flynn 2nd Mr. Morris to re-appoint Martin Gibson to the Zoning Board of Appeals for a term to 2021, carried.

After a brief discussion on minutes, Mr. Martin inquired about the farm animal waste issue brought up last month by a hiker on the Outlet Trail who reported it. What action was taken on this. Mr. Flynn replied no action, as it is not in the town of Torrey. Property in question is located in Town of Milo, Torrey has no jurisdiction, Leslie Church, Milo Supervisor, will be contacted about this potential pig manure runoff into the Outlet.

Mr. Petersen stated DEC was contacted on this concern, and after visiting the site determined there is no manure runoff into Keuka Outlet, therefore no violation.

Motion by Mr. Martini, 2nd Mr. Morris to approve April minutes, carried.

Old Business: Planning Board submitted Comp Plan update, Clerk reported response from Lt Matt Lochner NYS DEC regarding Section 5.3M Firearms Ordinance. Board questioned if this policy could be made into a law. Lt. Lockner stated in a letter that there is no law of such around, Canandaigua, Keuka or Seneca Lakes. It would be impossible to enforce with the Federal regulations in place below the High Water Mark along the lake. The Planning Board determined if the law could not be enacted, then section 5.3M should be removed in its entirety.

Motion by Mr. Martini 2nd Mr. Morris to approve changes in the Comp Plan as submitted by the Planning Board with the deletion of Policy 5.3M, carried.

Mr. James gave the code report. Issued 9 permits, 5 C of O, 1 Area Variance application, 5 site visits, 10 building progress visits, 130 miles traveled.

Mr. Chambers gave the highway report. After finding many issues with the loaned Admar sweeper it was returned. He found out that the broom can be attached to the back hoe, many townships have a dedicated tractor with the broom attached. On the back three point hitch, a water tank could be added. He will research this further.

Due to pooling water issues, a crossover pipe was lowered on Henderson Rd.

Torrey 3 had new bake drums all around after 175000 miles.

Installed two new culverts on Roy Road, while cleaning the ditch the Verizon phone line was cut in two. The line was buried only three inches deep, due to tile in the field the phone line runs out to the ditch, then along the ROW ditch line then back into the field. Verizon employees are on strike, the phone line is still not repaired.

Received an estimate from Seneca Stone to shim Arrowhead Beach Rd for \$ 45,000. This work has been scheduled for May 25th.

Laborer Josh Wood and he will attend Highway School at Cornell June 6th-9th.

Richard & Nye Nelson- Carlson Rd have written a letter requesting the Town Board to remove their properties from the proposed Water District 1. They have a good well and have the only residence on this road. The Water Committee and engineer will review this letter and make a recommendation to the Town Board.

Mr. Martini reported that Atlas Holdings had a teleconference regarding the status of the reopening of Greenidge Station. They have started from the beginning with the permitting process with both DEC and EPA. They are applying as a new plant, which with all the pollution control updates already installed will make it the cleanest producing power plant in the country. Previous teleconference indicated that the proposed Gas Pipe line from Town of Milo to the Greenidge Station has received approval to begin construction.

Motion by Mr. Flynn 2nd Mr. Morris that the Town Clean-up will be held on July 30 and 31st 8:00am - 2:00pm, carried.

Motion by Mr. Flynn 2nd Mr. Morris to adjourn at 8:00 pm carried.
